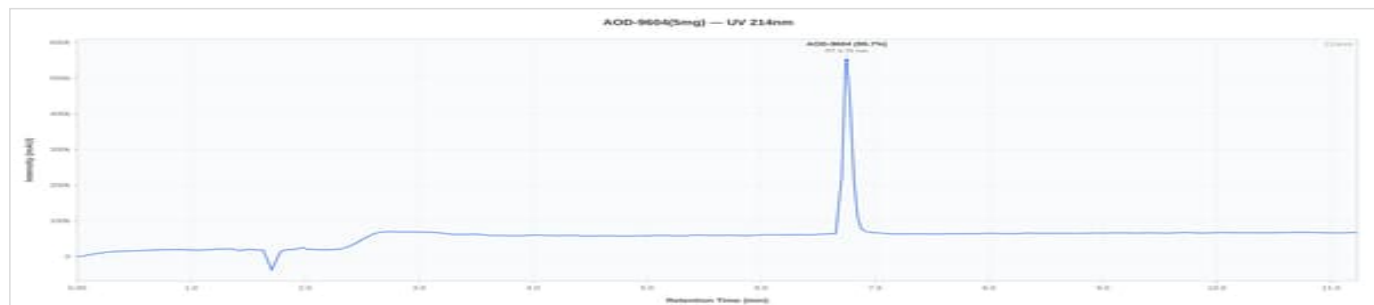

Notes & Methodology

1. Date Tested: 07/08/2026. Methods: Purity & Quant (HPLC); Heavy Metals (ICP-MS).
2. The sample was confirmed to be AOD-9604 by HPLC. Identification by chromatographic retention time comparison with a reference standard.
3. Endotoxin tested per USP <85> kinetic turbidimetric method. Acceptance criteria per client specification.
4. Peptide purity determined by RP-HPLC area normalization at 214 nm. Value represents the percentage of the target peptide relative to all peptide-related peaks. Non-peptide process-related impurities, if detected, are excluded from the calculation.
5. Chromatogram shown is representative: Conformity V2 (99.60% purity, closest to batch mean of 99.53%).
