Licensed contractors must qualify under state regulations that protect consumers against “fly-by-night” operators, who leave consumers holding the bag when something goes wrong.

It is tempting to trust whoever comes along with the cheapest bid, especially for smaller projects; but usually you get what you pay for, and a cheaper, unlicensed contractor may not be adequately insured or bonded. That could cost you a small fortune if anything goes wrong.

3. Compliance with the Law

Many people are surprised to learn that unlicensed contractors cannot legally perform jobs costing more than \$500.00.

8. To promptly acknowledge and act on all customer complaints, and in situations where complaints appear unreasonable and persistent, encourage the customer to initiate an approved third-party dispute settlement mechanism.
