RENTAL AGREEMENT

This Bounce House Rental Agreement (“Agreement”) is entered into on the date signed below, by and between **Blessings Playground LLC** (“Company”) and the individual identified below (“Client”). By signing this Agreement, the Client agrees to all terms and conditions set forth herein.

SECTION 1 — EVENT & RENTAL DETAILS

SECTION 2 — PAYMENT TERMS

Base Rates:

Unit	Base Rate (4 Hours)	Additional Hours
The Royal Castle (Blue/Purple)	\$150.00	\$50.00/hr
The Block Party Combo (Colorful Water Slide)	\$200.00	\$50.00/hr
Both Units	\$300.00	\$50.00/hr

A **non-refundable deposit of 25%** of the total rental fee is required at the time of booking to reserve the date. The remaining balance is due in full on the day of the

event, **prior to setup**. Blessings Playground LLC accepts cash, Zelle, Cash App, and Venmo. Checks are not accepted.

If the balance is not paid before setup begins, Blessings Playground LLC reserves the right to cancel the rental without refund of the deposit.

SECTION 3 — CANCELLATION & RESCHEDULING POLICY

The Client may cancel or reschedule the event by providing written notice (text or email) to Melissa Whitley at least **72 hours (3 days) before the event date**. In the event of a qualifying cancellation or reschedule, the deposit may be applied as a credit toward a future booking within 90 days.

Cancellations made **less than 72 hours** before the event will result in forfeiture of the deposit. No refunds will be issued for same-day cancellations.

Weather Policy: In the event of severe weather (lightning, heavy rain, or high winds exceeding 25 mph), Blessings Playground LLC reserves the right to cancel for safety reasons. In such cases, the Client will receive a full credit toward a future booking. Blessings Playground LLC does not issue cash refunds for weather cancellations.

SECTION 4 — SETUP & DELIVERY TERMS

Blessings Playground LLC will deliver, set up, and retrieve the rental unit(s). The Client must ensure the following conditions are met at the event location:

- A **flat, grassy or paved area** of sufficient size is available and clear of debris, rocks, sharp objects, and animal waste prior to the Company's arrival.
- The setup area must be **within 50 feet of a standard 110V electrical outlet** for the blower. Extension cords are not provided.
- **Overhead clearance of at least 15 feet** must be available (no low-hanging branches, power lines, or structures).
- The Client must be present at the event address at the agreed delivery time. If the Client is not present within 15 minutes of the scheduled delivery time, Blessings Playground LLC reserves the right to cancel the rental without refund of the deposit.

- The Client is responsible for obtaining any required **permits or HOA approvals** for the event location.

SECTION 5 — RULES OF USE & SAFETY GUIDELINES

The Client agrees to enforce the following safety rules at all times during the rental period. Failure to do so may result in immediate retrieval of the equipment with no refund.

General Rules:

- Adult supervision is **required at all times**. Children must never be left unattended inside or around the bounce house.
- **No shoes, glasses, jewelry, or sharp objects** are permitted inside the bounce house.
- **No food, drinks, gum, or candy** inside the bounce house at any time.
- **No silly string, confetti, paint, or face paint** near or inside the bounce house.
- **No flips, roughhousing, or climbing on the outside walls** of the bounce house.
- Children with **physical limitations, injuries, or medical conditions** should not use the equipment without physician clearance.

Capacity Rules — The Royal Castle:

- Maximum weight capacity: **600 lbs total** inside the bouncing area at one time.
- Recommended age range: **3 to 10 years old**.
- Maximum of **8 children** inside at one time.

Capacity Rules — The Block Party Combo:

- Maximum of **6 children** inside the bouncing area at one time.
 - The water slide feature requires a connected garden hose (not provided by Blessings Playground LLC).
 - The splash pool must be supervised at all times when water is in use.
 - The splash pool may be used as a **ball pit (dry)** as an alternative to water use.

SECTION 6 — DAMAGE POLICY

The Client is financially responsible for any damage to the rental equipment caused by misuse, negligence, or violation of the rules set forth in Section 5. Normal wear and tear is expected and is not the Client's responsibility.

Damage charges are as follows:

Type of Damage	Estimated Charge
Small tears or punctures (repairable)	50–150
Large tears or unrepairable damage	300–800
Total loss / destruction of unit	Replacement cost (up to \$1,500)
Staining from food, paint, or silly string	75–200 cleaning fee

Blessings Playground LLC will assess damage upon retrieval and notify the Client within 24 hours. Payment for damages is due within 7 days of notification.

SECTION 7 — LIABILITY WAIVER & RELEASE

PLEASE READ THIS SECTION CAREFULLY. BY SIGNING BELOW, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS.

The Client, on behalf of themselves and all participants, guests, and minors attending the event, hereby agrees to the following:

1. The Client acknowledges that the use of inflatable bounce houses involves **inherent risks of physical injury**, including but not limited to bumps, bruises, sprains, fractures, and other injuries that may result from normal use or misuse of the equipment.
2. The Client **voluntarily assumes all risks** associated with the use of the rental equipment and the event.
3. The Client agrees to **release, indemnify, defend, and hold harmless** Blessings Playground LLC, its owner Melissa Whitley, employees, contractors, and agents from any and all claims, demands, damages, losses, costs, or expenses (including

attorney's fees) arising out of or related to the use of the rental equipment, whether caused by negligence or otherwise.

4. The Client agrees that **Blessings Playground LLC is not responsible** for any injuries, accidents, or incidents that occur during the rental period, including those caused by failure to follow the safety rules outlined in Section 5.
 5. The Client confirms that they are **18 years of age or older** and have the legal authority to enter into this Agreement on behalf of all participants.
 6. This Agreement shall be governed by the laws of the **State of North Carolina**. Any disputes arising under this Agreement shall be resolved in Montgomery County, North Carolina.

The Client grants Blessings Playground LLC permission to photograph or video the rental setup (not the children) for use in marketing materials, social media, and the company website, unless the Client indicates otherwise below:

SECTION 9 — ENTIRE AGREEMENT

This Agreement constitutes the entire agreement between the parties and supersedes all prior discussions, representations, or agreements. No modification of this Agreement shall be valid unless made in writing and signed by both parties.
